## Photo Session Contract

Monet Vineyards is a private estate that we open for special functions, retreats and photo sessions by appointment only. We have cultivated this garden sanctuary as both our home and as a creative backdrop and muse for visitors. We appreciate your utmost respect for our estate grounds as you enjoy the space.

The following are a few guidelines to assist us in maintaining the estate:

-Photo shoot fee is \$75 per hour. (NOT INCLUDING SALES TAX)

-Payment:

We accept CREDIT CARD and DEBIT CARD

-After the first hour, increments of 1/2 of an hour usage at \$37.50 each are available.

**-Photo shoots are not reserved until the policy has been signed, returned and payment received.**

**-If a photo shoot extends beyond the time allocated, the client will be charged for an extra \$37.50, even if time usage is under half of an hour.** We regrettably enforce this policy to limit photo sessions that run overtime without pay. Please consult with your photographer to guarantee your photo shoot wraps up within the set time constraints to avoid being charged.

- CANCELLATION POLICY: **Regrettably we don't offer refunds on cancellations due to the number of requests on the same day and time.** However, we will be happy to reschedule your photo shoot for another date.

- Our space is currently not available for the following photos shoots:  
  . family photo sessions that include children under the age of 12 years of age.

-Monet is a private estate, and gates are locked. Please enter Monet Vineyard's grounds no earlier than five (5) minutes before a scheduled photo shoot.

- Entrance is on 14698 NE 212th Ave, Brush Prairie, WA 98606. **NO VEHICLES ALLOWED BEYOND THE PARKING LOT.**

-Please make every effort to be punctual when visiting Monet Vineyards for a photo session.

Should there be a delay, the client is required to contact Monet Vineyards immediately.

A no-show after 30 minutes without communication from the client will result in a cancellation of the photo session.

-In the event of adverse weather conditions, please call in advance, and we're happy to work with you to reschedule the session.

- BRIDAL PARTY: The bridal party must step down from the terrace after their photos are completed. BRIDAL PARTY IS NOT ALLOWED TO WONDER ON THE TERRACE OF THE HOUSE.

-Props for photo sessions need to be reviewed for liability reasons via a conversation with Monet Vineyards before being brought to our venue. Any props brought into Monet Vineyards without permission are subject to refusal.

- As Monet Vineyards is both a private residence as well as a venue, we ask that all visitors refrain from exploring the property without permission. Areas available for photo shoots include: around the exterior of the house, the garden, and the vineyards. Clients are not allowed to wander freely beyond the locations above. Please ask if you desire access to another area, and we will be happy to consider your request.)

- Food, drinks, etc., are not permitted inside Monet Vineyards.

- A bathroom facility is currently not available at Monet Vineyards. Please take care of your needs before arriving at Monet Vineyards. We thank you in advance for understanding that our resident bathroom is not available to clients.

-Clients that do not adhere to this photo shoot policy during the photo session may be asked to leave the venue without a refund.
